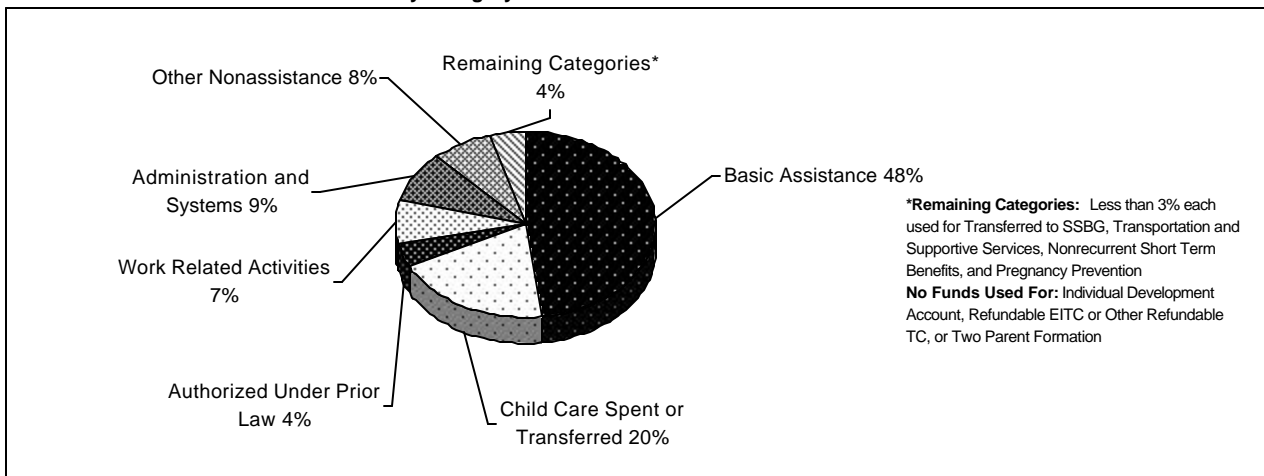

Explanation: In FY 03, a number of states reported "adjustments" to prior year MOE reporting. In official reporting, current year spending and adjustments for prior years are aggregated together, resulting in a net total less than actual FY 03 spending. This table disaggregates FY 03 spending from prior-year adjustments.
