

State-Level Impact of Federal Budget Agreement on Medicaid

Leaders of the Senate and House Budget Committees announced a federal budget agreement today that includes approximately \$10 billion in Medicaid cuts over five years (although the cuts are not scheduled to begin until 2007). The table below shows how much cuts of this magnitude could cost each state (if the cuts were distributed across the states in proportion to their current federal Medicaid funding levels).

The tables on page 2 show how much each state could lose in 2007 alone if these cuts were distributed equally over a four-year period. To give a sense of what such cuts could mean in terms of health coverage, the tables also show how many children, seniors, or people with disabilities in each state could be covered with that amount of money in 2007.
